WITH 208 ACTIVE VOLUNTEERS CONTRIBUTING 6,670 VOLUNTEER HOURS, COMPLETING APPROXIMATELY 279 PROJECTS IN 100 HOMES. DURING THE QUARANTINE, WE ATTEMPTED TO CALL ALL 1,000 OF OUR PREVIOUS HOMEOWNERS AND DO WELLNESS CHECKS TO MAKE SURE OUR OLDER ADULT HOMEOWNERS HAD THEIR BASIC NEEDS COVERED.
